Reference Commission Advt. No. 4/2009, dated 12.8.2009, Cat. No.1 to 5 and 7 which published on 13.8.2009 in Dainik Bhaskar, Amar Ujala, Punjab Kesri, Hindustan Times (Chandigarh) and Indian Express (Delhi) newspapers and corrigendum dated 19.8.2009, 26.8.2009 & 12.3.2010 for recruitment of various posts of Masters and JBT Teachers, Education Department, Haryana.

Keeping in view of the Education Department, Haryana letter No. 8/4-2008/Co(1), dated 2.4.2010, **such candidates who have passed the 3<sup>rd</sup> School Teacher Eligibility Test (STET) for Masters and JBT Teachers conducted in the month of December, 2009 have also been considered eligible against Advt. No. 4/2009, dated 12.8.2009.** These candidates may apply now up to 26.4.2010. However, such candidates who had not qualified the School Teacher Eligibility Test (STET) on the closing date i.e. 14.9.2009 and applied earlier without STET certificate will be required to apply afresh along with STET certificate and proof of depositing the application fee as they will be exempted from payment of fee. The remaining other eligible candidates who had already applied in response to aforesaid advertisement need not to apply afresh as their earlier applications will be considered.
