PUBLIC NOTICE

Schedule for verification of original documents/ interview of petitioners (Guest Teachers) only in terms of SLP No. 9247 of 2010 for the post of JBT Teacher against Advt. No. 4/2009, Cat. No. 1, Education Department, Haryana.

Reference Commission Notice dated 26.8.2010 which published in various newspapers for conducting verification of documents/ interview of eligible petitioners (Guest Teachers) in compliance of orders of the Hon'ble Supreme Court in SLP No. 9247 of 2010- Gopal Singh & ors. Vs. State of Haryana & ors. alphabetically for the post of JBT Teachers Advt. No. 4/2009, Cat. No. 1.

The Hon'ble Apex Court vide interim orders in the aforesaid SLP has given liberty to the petitioners (Guest Teachers) to participate in the selection process for various posts including JBT Teachers. In pursuant to said orders the Commission has notified the schedule vide Public Notice dated 26.8.2010 for verification of the documents/ interview alphabetically on 3.9.2010, 4.9.2010, 6.9.2010 and 8.9.2010 **only of eligible petitioners (Guest Teachers) for the post of JBT Teachers.**

On scrutiny of the application forms, it has been found that the petitioners (Guest Teachers) possessing the qualification of B.A. B.Ed. have also made applications for verification of documents/ interviews for the post of JBT Teachers against Advt. No. 4/2009, Cat. No. 1. As per rules and law laid down by the Hon'ble Supreme Court in the case of P.M.Latha & anr. Vs. State of Kerela & ors. JT 2003 (2) SC 423, and Dalip Kumar Ghosh & ors. Vs. Chairman & ors. 2005(4) RSJ 607 SC, such candidates are ineligible who possesses the qualification of B.A. B.Ed. for the post of JBT Teacher. Therefore, in view of the well settled law of the Hon'ble Apex Court, such petitioners (Guest Teachers) having qualification of B.A. B.Ed. are not eligible to participate in the selection process for the post of JBT Teachers. The Education Department, Haryana vide letter dated 6.6.2006 appointed such Guest Teachers having the qualification of B.A. B.Ed. only as a stop-gap-arrangement but the regular recruitment is required to be made strictly as per rules and advertisement, according to which the candidates possessing the qualification of B.A. B.Ed. are not eligible for the post of JBT Teacher. **Hence, the petitioners (Guest Teachers) possessing the qualification of B.A. B.Ed. are advised not to report for verification of documents/ interview for the post of JBT Teachers on 3.9.2010, 4.9.2010, 6.9.2010 and 8.9.2010 as they are ineligible and no verification of documents/ interview will be conducted by the Commission.**

Note:-Candidates other than eligible petitioners in SLP No. 9247 of 2010 need not require to report for verification of documents/ interview.
