The call letters will be issued separately and eligible candidates are advised to attend the interview on the date & place mentioned in the call letter. If any candidate, whose name starts with Alphabet O, P, Q, R, S, T, U, V, W, X, Y & Z and possesses the required cut off points as mentioned in the aforesaid shortlisting Notice does not receive call letter upto **03-11-2010**, he/she is advised to contact the Haryana Staff Selection Commission, Panchkula along with original Mark Sheets/Certificates, Photograph, Receipt of Registry etc. in support of his/ her qualifications and proof of having deposited the requisite fee during the office hours for receipt of duplicate Roll No. as per schedule given below:-

The candidates are advised to attend the interview on the prescribed dates as mentioned in their call letters strictly and after the prescribed date no request will be entertained for conducting his / her interview on other date.

However, candidates who have applied against public notice dated 10-11-2009 will be considered eligible.
