Reference Commission advertisement No. 15/2007 Category No. 06 dated 07-12-2007 read with corrigendum dated 07-10-2008 and 17-03-2010 which published in the various newspapers for recruitment of **130 Posts of Sub Inspector, Food & Supplies Department Haryana.**

Educational Qualification: -

- I. Matric 2nd Division or its equivalent.
- II. Hindi/Sanskrit upto Matric Standard.

Keeping in view the large number of applications and as per condition of advertisement, the Commission has decided to shortlist the candidates for interview in the respective category on the basis of academic qualification. The minimum cut off points as per under mentioned formula for each category is given below: -

The Criteria for selection adopted by the Commission will be as under:-

All the short listed candidates with the above mentioned cut off or higher will be called for interview. The eligible candidates are advised to read the above mentioned notice carefully and appear for Interview to be commenced **in months of November & December, 2010** as per schedule which will be published separately and as per dates indicated in the call letters. **However, such candidates who do not possess the minimum cut off points for short listing under their respective categories are advised not to contact the Commission in this regard. Call letters for the interviews for the above mentioned posts are being issued separately.**

Note:-

While calculating cut off points the candidates are advised to multiply their percentage of Matriculation only with 0.58 and in case they possess the qualification of 10+2 or Graduation then add point 1 (for 10+2) and points 2 (for graduation & above) respectively as the case may be, as per formula explained above.
